Today, one in two companies in France does not find the skills it needs.

Today, the unemployment rate for unskilled jobseekers is 18% - compared to 6.5% for qualified jobseekers.

The digital and ecological transitions will greatly increase the need for reskilling and upskilling. This is a challenge for France as well as for the rest of the world, which we must take into account straightaway. This is why France is investing extensively in lifelong education and training.

Success in the knowledge and skills economy is a triple challenge:




A worldwide pioneering and robust solution


France is the first country in the world to create a mobile application dedicated to vocational training, lifelong learning. This new digital public service, open to 28 million French people, is 100% designed and developed by the State and its operators.



EASY TO NAVIGATE: THE DIRECT GATEWAY TO TRAINING AND SKILLS

The app can be downloaded on Google Play and the App Store. Searches are carried out using a geolocation tool and allow you to sort and select training courses by type. With just a few clicks, each user will be able to choose, book and pay for their training online, without any intermediary, 24 hours a day, 7 days a week, anywhere in France.







CERTIFIED TRAINING COURSES COVERING ALL FIELDS: CREATING A NEW MARKETPLACE

All training courses available and accessible via the website or the mobile application MonCompteFormation are listed in the National Directory of Professional Certifications (RNCP). Direct evaluation by the training recipient will contribute to improving the quality of training offers; the range of training will be enriched according to the needs expressed by users.


A SERVICE ACCESSIBLE TO PEOPLE WITH DISABILITIES

5 PREVENTING THE RISK OF FRAUD
